TO AMEND THE CITY OF OLEAN'S LOCAL HIGHWAY INVENTORY AS PER RECOMMENDATIONS SUBMITTED BY THE NEW YORK STATE DEPARTMENT OF TRANSPORTATION

WHEREAS, the New York State Department of Transportation has made various recommendations of changes to the City of Olean's Local Highway Inventory,

RESOLVED, that the City of Olean hereby amends the 2018 City Local Highway Mileage Inventory of City Streets as follows:

- 1. Amend Franchot Boulevard distance to .15 to reflect that a portion of the roadway is a single purpose road within a public property that only provides access to facilities within the property;
- 2. Amend Gulf Street distance to reflect an extension of .29 to .4;
- 3. Amend to reinstate Higgins Avenue with a distance of .07 miles;
- 4. Amend Sunrise Drive distance to reflect an extension of .12 to .2; and
- 5. Amend West Sullivan Street from North Seventeenth Street to .05.
