TO DESIGNATE A GRASS CUTTING FEE SCHEDULE

WHEREAS, Chapter 16, Section 16-2 of the City of Olean Code of Ordinances authorizes the City of Olean Code Enforcement Office to enforce the abatement of noxious weeds and grass; and

WHEREAS, if the owner of a parcel fails to cut, or cause to be cut, noxious weeds and grass from the lot after proper notification by the Code Enforcement Office, a Code Enforcement Officer may arrange for the mowing of the premises and the property owner shall be charged with the cost thereof; and

WHEREAS, the Common Council desires to designate a fee schedule for the removal by the City of Olean of such noxious weeds and grass upon failure by the property owner to cut or cause to be cut said nuisance weeds and grass;

Now, THEREFORE, BE IT RESOLVED, that the Common Council of the City of Olean designates the following as the fee schedule for the removal of noxious weeds and grass in accordance with Section 16-2 of the City of Olean Code of Ordinances:

Grass Cutting Fee Schedule

1/4 Acre Lot	\$50
½ Acre Lot	\$75
1 Acre Lot	\$100
1 1/4 Acre Lot	\$150
1 ½ Acre Lot	\$175

2 Acre Lot of Greater Cost equal to reimbursement of contractor cost to cut grass
